APPLICATION AND REGISTRATION FOR VEHICLE PERMIT (FORM #1-V)

VEHICLE RESTRICTIONS: Passenger vehicles only. NO Commercial vehicles of any kind are permitted in the Villas, nor trucks of one ton or more, nor recreational vehicles, campers, trailers, boats, nor motorcycles, nor vehicles that are damaged, have incomplete body work, or otherwise "unsightly", or not mechanically operable or licensed, registered and insured. Storage of vehicles not moved for more than 7 days is prohibited. NO PARKING ON STREET, SIDEWALKS, GRASS, other than the designated TWO PARKING SPACES allowed PER UNIT. (Guest parking is available for occasional guests with procurement of a guest or temporary parking permit.) **A PHYSICAL INSPECTION OF VEHICLE IS REQUIRED FOR PERMIT. NO REPAIR WORK MAY BE DONE ON VEHICLES WITHIN THE COMPLEX.**
